FLOURIDE ACTION NETWORK (FAN) - IN JANUARY 2011, THE U.S. EPA'S OFFICE OF PESTICIDES ANNOUNCED IN THE FEDERAL REGISTER THAT THEY AGREED WITH ALL THE OBJECTIONS SUBMITTED TO THEM FROM A COALITION OF THREE ADVOCACY GROUPS (FLUORIDE ACTION NETWORK, ENVIRONMENTAL WORKING GROUP, AND BEYOND PESTICIDES) AND ANNOUNCED A PROPOSED PHASE-OUT OF THE FOOD FUMIGANT SULFURYL FLUORIDE. JONATHAN FLEUCHOUS OF EPA'S OFFICE OF GENERAL COUNSEL, NOTED THAT THIS WAS A "FIRST" IN THE HISTORY OF EPA. SINCE THEN, EPA HAS SOLICITED MORE PUBLIC COMMENT ON THEIR PROPOSAL. WE HAVE WORKED DILIGENTLY WITH OUR NONPROFIT LAWYER, PERRY WALLACE ESQ. ON THIS SUBMISSION. FAN HAS BEEN INVOLVED IN THE SULFURYL FLUORIDE ISSUE SINCE SEPTEMBER, 2001 WHEN EPA RESPONDED TO DOW CHEMICAL'S FIRST REQUEST TO USE IT. ALSO IN JANUARY 2011, THE EPA'S OFFICE OF DRINKING WATER TOGETHER WITH THE DEPARTMENT OF HEALTH & HUMAN SERVICES PROPOSED A LOWERING OF THE LEVEL OF FLUORIDE USED IN FLUORIDATION SCHEMES. FAN SUBMITTED SUBSTANTIVE COMMENTS ON THIS. OUR WEBSITE CONTAINS THE MOST INFORMATION ON FLUORIDE AND IS A MAJOR RESOURCE FOR REPORTERS, CITIZENS, AND VARIOUS OFFICIALS. WE STRIVE FOR ACCURATE DATA, AND UPDATE IT FREQUENTLY. OUR CAMPAIGN DIRECTOR, STUART COOPER, CAMPAIGNED TO GET THE STATE OF NEW HAMPSHIRE TO ADOPT LEGISLATION THAT WOULD REQUIRE LANGUAGE ON WATER BILLS THAT ARE SENT OUT TO UTILITY CUSTOMERS TO WARN THEM AGAINST USING FLUORIDATED WATER IN THE PREPARATION OF BABY FORMULA. WHILE THE BILL WAS WELL RECEIVED, IT FAILED, BUT WAS REVIVED IN 2012 AND PASSED. FAN WAS MENTIONED IN THE NEWS MEDIA ON A REGULAR BASIS THROUGHOUT THE YEAR - SEE HTTP://WWW.FLUORIDEALERT.ORG/ABOUT/FAN\_NEWS/. OUR DIRECTOR, PAUL CONNETT, TRAVELED TO MANY CITIES THROUGHOUT THE US, CANADA, UK, AND NEW ZEALAND, ON THE FLUORIDATION ISSUE.
