BOARD ORDER

On December 1, 2006, the Arizona State Board of Dental Examiners reviewed the information presented by the investigative panel and voted to accept the Findings of Fact as follows:

FINDINGS OF FACT

1. There is a history, clinical dated 3/8/95, 7/7/04. ≡
2. AF: panorex 3/8/95 diagnostic, two bitewing x-rays 3/8/95, JF: panorex 3/8/95 marginally diagnostic, two bitewing x-rays 3/8/95 fair, 5/5/99 bitewing x-rays fair, 7/7/04 bitewing x-rays hard to read copies. ≡
3. Diagnosis not specific for either patient. ≡
4. Treatment plan done as procedure by procedure. ≡
5. Difficult to tell from x-rays but crowns have history of recementing, hole in crowns on occlusal and redone all crowns on both patients by another dentist. Were replaced with PFG, which was what patients started with. ≡

and CONCLUSIONS OF LAW as follows:

The facts as stated represent UNPROFESSIONAL CONDUCT as defined at A.R.S. Section 32-1201(20)(n) which states "Any conduct or practice which does or would constitute a danger to the health, welfare or safety of the patient or the public" and as such, constitute grounds

for DISCIPLINARY SANCTIONS under A.R.S. Sec.
32-1263(1).

and ISSUED the following order:

CONTINUING EDUCATION for credit of SIX (6) hours in the
area of DENTAL MATERIALS TO BE COMPLETED IN SIX (6)
MONTHS.

HOME STUDY COURSES ARE NOT ACCEPTABLE.

PRE-APPROVAL:

IN BOARD ORDERS OF CONTINUING EDUCATION, PRIOR APPROVAL
OF THE COURSES BY THE BOARD OF DENTAL EXAMINERS OR ITS
DESIGNEE IS MANDATORY AND THE REQUEST MUST BE RECEIVED
AT LEAST TEN BUSINESS DAYS PRIOR TO THE DATE OF THE
COURSE.

It is the licensee's responsibility to locate course(s)
and submit the information for prior approval. Board
staff CANNOT assist you in locating an appropriate
course.

VERIFICATION OF ATTENDANCE:

RESPONDENT MUST FILE VERIFICATION OF COMPLETION WHICH
SHALL BE SENT TO THE BOARD OFFICE WITHIN FIVE BUSINESS
DAYS AFTER THE COURSE IS COMPLETED. Verification shall
be by cancelled checks, attendance slips, if any, and a
copy of the notes taken during the course.

These hours of Continuing Education are IN ADDITION TO
THE HOURS REQUIRED AT TIME OF RENEWAL.

A licensee has the right to PETITION FOR REHEARING or
REVIEW of the Order pursuant to A.R.S. Section
32-1263.02(E). According to A.R.S. Section 41-1092.09,
as amended, the PETITION must be filed with the Board's
Executive Director within thirty (30) days after
personal service of this Order or within thirty-five
(35) days from the date of the mailing if the Order
was served by Certified Mail. Pursuant to A.A.C.
R4-11-1701(C), the PETITION must set forth legally


sufficient reasons for granting the rehearing or review. The filing of a PETITION FOR REHEARING or REVIEW is required to preserve any rights of appeal to the Superior Court that the licensee may wish to pursue.

THIS ORDER SHALL BE EFFECTIVE and IN FORCE UPON THE EXPIRATION OF THE AFOREMENTIONED TIME PERIOD FOR FILING A MOTION FOR REHEARING OR REVIEW WITH THE BOARD. However, the timely filing of a motion for rehearing or review shall stay the enforcement of the Board's Order unless, pursuant to A.A.C. R4-11-1701(F), the Board has expressly found good cause to believe that the Order shall be effective immediately upon issuance and has so stated in this Order.
