The Board of Medical Examiners (Board) is the state agency responsible for licensing, regulating and disciplining certain health care providers in the State of Oregon. John Gambee, M.D. (Applicant), is an applicant for a medical license in the State of Oregon.

2.

Applicant submitted an application to practice medicine in Oregon dated May 20, 1996. As part of the application investigation, it was verified that Applicant's license to practice medicine in the State of Oregon had been revoked by Final Order dated October 13, 1994. Pursuant to ORS 677.220, the Board considered Applicant's application on January 17, 1997 and authorized issuance of a limited license Special Purpose Examination (SPEX) pursuant to OAR 847-10-064, contingent upon Applicant requesting a voluntary limitation pursuant to ORS 677.410 containing the terms articulated in paragraph 2 of the Board's letter to Applicant dated January 22, 1997 (attached

///

1 hereto as Exhibit A). Applicant accepted those specific terms in
2 a letter dated March 12, 1997 (attached hereto as Exhibit B).

3 3.

4 Applicant understands that the Board's statutory mandate is
5 to protect the public and, consequently agrees to the entry of
6 this Stipulated Order of Licensure Pursuant to Voluntary
7 Limitation permitting him to practice medicine in the State of
8 Oregon upon the conditions specified below.

9 4.

10 Applicant will receive a limited license Special Purpose
11 Examination (SPEX) pursuant to OAR 847-10-064, which provides him
12 with a limited license until the results of his SPEX are available
13 to the Board. (Applicant has agreed in his letter dated March 12,
14 1997, to take the SPEX within 90 days). Upon successful
15 completion of the SPEX, the only limitation on Applicant's license
16 will be the voluntary limitation pursuant to ORS 677.410 specified
17 in this order.

18 5.

19 The license issued pursuant to this order is expressly
20 contingent upon compliance with the following Voluntary
21 Limitation:

22 5.1 All patients treated by Applicant will sign an informed
23 consent agreement stating the following:

24 A. Dr. John Gambee is not a primary care physician;

- 1 B. The patient's need for a current primary care physician
2 prior to Dr. John Gambee treating the patient;
- 3 C. Patient authorization for release of medical records to
4 all primary care and specialty physicians.
- 5 5.2 Applicant must complete 50 hours of continuing education
6 annually in fields of traditional medicine.
- 7 5.3 All patient charts will contain a current database
8 either created by Applicant or obtained from patient's primary
9 care physician documenting:
- 10 A. Patient complaints, history, appropriate physical
11 examination and laboratory testing, diagnosis, and
12 consent to treatment pursuant to ORS 677.097.
- 13 5.4 Periodic review of patient charts by physician to be
14 approved by the Board at Applicant's expense.

6.

15 Evidence of violation of the terms of this order shall be
16 grounds for disciplinary action by the Board pursuant to ORS
17 677.205.


18 Applicant and the Board understand that by issuing a license
19 pursuant to the terms of this stipulated limitation, Applicant
20 waives his right to a contested case hearing under the Oregon
21 Administrative Procedures Act or to any appeal from an adverse
22 decision thereunder. Applicant and the Board also understand that
23 this is a final order under Oregon law and therefore is a public
24 record. This stipulated limitation, however, is not a
25 disciplinary action and is not reportable as an adverse action to
26 the National Practitioner Data Bank nor the Federation of State

1 Medical Boards. This stipulated limitation
2 will remain in effect until Board review pursuant to ORS 677.410.

3 IT IS SO STIPULATED this 31 day of March, 1997.


